

2024 SCHOLARSHIP FOUNDATION APPLICATION

The Texas Food & Fuel Association Scholarship Foundation will award scholarships to outstanding students in the state of Texas. This includes scholarships sponsored by the Texas Food & Fuel Association and the Wranglers Council. In total, up to four (4) scholarships will be awarded to exemplary high school seniors graduating from accredited high schools within the state of Texas.

APPLICATION PROCEDURE

Applications may be typed or handwritten, must be completed in full, and be accompanied by the required documentation.

Deadline: The deadline for submission of the applications to be returned to the school for review will be set by the individual participating school. However, all nominated applications to the Texas Food & Fuel Association Scholarship Foundation must be received or postmarked by mail or emailed to ahicks@tffa.com no later than Monday, June 3, 2024.

APPLICANT ELIGIBILITY

Eligible applicants must meet criteria of citizenship, residence, academic standing, and demonstration of leadership, character, and economic need. In addition, eligible applicants must include a recommendation from his/her high school personnel (education) administrator and submit college/university enrollment plans.

The applicant must also be a high school senior who is:

- 1) A dependent child of a Texas Food & Fuel Association member, or;
- 2) Actively employed by a marketer, retailer or supplier member of the Texas Food & Fuel Association.

Initial recipients shall be graduating high school seniors and each must be a United States citizen and qualify as children younger than 21 years old at the time of the application (born, adopted or under custody of court recognized guardian) of the member or the member's employee.

Citizenship: Applicant must be a citizen of the United States or be born in the United States and be a resident of the State of Texas. If place of birth of applicant as indicated on application and/or transcript is other than the United States, appropriate proof of citizenship must be furnished with application.

Residency: The applicant must be a graduating senior or have been a qualified graduate of one of the accredited public/private senior high schools in the participating school district.

Academic Standing: The applicant must be a graduating high school senior ranked in the upper one-half (1/2) of his/her graduating class at the completion of his/her first semester of the senior year or at the time of the applicant's graduation. This ranking is to be verified as part of the official transcript or by an accompanying certification from an appropriate school official. Applicant's transcript must reflect that he/she has successfully passed the TAAS or equivalent replacement MASTERY/EXIT LEVEL exam at the time of application.

Graduation: The applicant must be eligible to attend an accredited college following the awarding of the scholarship or have been a mid-term graduate at the conclusion of the semester immediately preceding (within one year) the awarding of the scholarship.

Collegiate Acceptance/Enrollment: The applicant must enroll or plan to enroll in either a college, university, trade-tech school, or other recognized institution of higher education and participate in a curriculum leading to a bachelor's degree. Applicant must have applied for admission at time scholarship application is submitted and if available at the time of application, a copy of the acceptance letter for enrollment should be included with the application. Applicant must indicate choice of major and career planned.

Activities: Leadership potential and character of the applicant should be demonstrated through applicant's responses to the categories of the application detailing school, extracurricular and community activities and achievements. Personal references will provide additional information as well.

Narrative: Each applicant must include a typed or handwritten narrative of no more than two, 8 ½" x 11" sheets, double-spaced. In this narrative, the applicant may supply any information that he/she feels is pertinent to the application receiving proper consideration. Applicant's name, address and high school must appear as a heading to the narrative in the upper right-hand corner of page one.

Photo: Each applicant must furnish a recent headshot, no smaller than 2" x 3". The color photo should be enclosed in an envelope that is attached to the application. Do not staple or tape the photo directly to the application. **Do not send Polaroid, instant photos or color photocopies of photographs.** If photo is sent by email, it must be in a high-resolution format. Photo should be identified with applicant's name typed on a label affixed to photo or written on back.

References: Each applicant may submit up to three (3) letters of personal reference. References may be either typed or handwritten and should include the name, address and daytime phone number of the person making the recommendation, as well as an indication of the person's relationship to the applicant (teacher, minister, employer, relative, etc.) These letters must be attached to the application. References should indicate knowledge of applicant's character, determination to pursue a college education and any other factors that will assist evaluation. No more than three letters may be submitted per applicant and no letter should exceed two pages in length.

Documentation: Each application must be accompanied by an official transcript showing academic average and grading scale through four years of high school, class size and official ranking of applicant; proof that applicant has passed the TAAS MASTERY/EXIT LEVEL exam; narrative; photo; references; proof of citizenship. If the transcript does not list the school's grading scale, a letter with this information must be included from the registrar or counselor.

Deadline: All applications to the Texas Food & Fuel Association Scholarship Foundation must be received or postmarked by mail or emailed to ahicks@tffa.com no later than Monday, June 3, 2024.

The Texas Food & Fuel Association Scholarship Foundation will not accept applications delivered in person. Please mail your application.

Applications should be stapled together only. Do not bind. Do not put in sheet protectors. Applications will not be returned and become the property of the Texas Food & Fuel Association Scholarship Foundation with all due measures for identity protection in place.

EVALUATION PROCEDURE

For the purposes of evaluation of applicants, a selection committee independent of the Texas Food & Fuel Association Scholarship Foundation will review all properly completed applications. Incomplete applications will not be considered. A rating sheet will be used as part of the evaluation process, with each application scored individually on the basis of the criteria outlined in the eligibility section.

The recommendations of the evaluation committee will be referred to the Texas Food & Fuel Association Scholarship Foundation. All applicants will be notified once the independent selection committee has made their selections.

NOTIFICATION OF RECIPIENTS

Recipients of scholarship awards will be notified individually by the Texas Food & Fuel Association Scholarship Foundation. The Texas Food & Fuel Association Scholarship Foundation will also notify the central administrative office of each participating school district of the names of the recipients of the scholarships.

Notification will be made prior to the completion of the spring semester in which the scholarship is to be awarded. The scholarship winners will be announced during the Southwest Fuel & Convenience Expo, to be held in San Antonio, June 25-27, 2024.
